**Insolvency of IIB Luxembourg S.A.**

Reference is made to the trust deed (the "**Trust Deed**") dated 16 February 2010 made between IIB Luxembourg S.A. (the "**Issuer**") and BNY Corporate Trustee Services Limited (the "**Trustee**") pursuant to which the Issuer issued the US\$200,000,000 11% Loan Participation Notes due 2013 (the "**Notes**"). Reference is also made to the loan agreement (the "**Loan Agreement**") dated 12 February 2010 made between IIB Luxembourg S.A. (the "**Issuer**") and The International Industrial Bank, Joint Stock Company (the "**Borrower**"), pursuant to the terms of which the Issuer made a loan of US\$200,000,000 to the Borrower.

Capitalised terms used in this notice and not defined in this notice shall have the meanings set out in the Trust Deed. Previous notices have been sent to Noteholders and should be referred to for background and reference. In the notice dated 14 November 2011, Noteholders were informed that the directors of the Issuer may commence bankruptcy proceedings under Luxembourg law if funding were not made available to the Issuer to discharge certain of its outstanding obligations.

**Insolvency of the Issuer:** by way of judgment dated 6 January 2012 of the 15<sup>th</sup> Chamber of the Luxembourg District Court, sitting in commercial matters (*tribunal d'arrondissement de et à Luxembourg, siégeant en matière commerciale*, hereinafter the "**Court**"), bankruptcy proceedings have been opened over the Issuer, at the Issuer's request (*faillite sur aveu*).

The Court has appointed as insolvency receiver (*curateur de faillite*) Maître Max Mailliet, avocat à la Cour, having his office at L-2342 Luxembourg, 52 rue Raymond Poincaré (hereinafter the "**Curateur**").

**Filing of Claim:** following the commencement of bankruptcy proceedings, creditors of the Issuer are required to submit a proof of claim to the Curateur in respect of amounts owed to them by the Issuer. The Curateur recognises the Trustee as the creditor in respect of the Notes, and accordingly the Trustee will procure that a claim is submitted in respect of the amounts owing under the Notes and the Trust Deed. Noteholders are not required to submit their own claims in respect of the Notes. Accordingly, Noteholders do not need to take any action at the present time as a result of the commencement of bankruptcy proceedings.

**Verification of Holdings:** please note that in any correspondence with the Trustee, the holders of the Notes will be required to submit proof of their holding together with due written authorisation and any other necessary evidence as may be required by the Trustee. In order to facilitate communications with the holders of the Notes and the provision of information such as documents, the Trustee hereby invites all holders who have not already done so to make themselves known to the Trustee and to verify their holdings of the Notes to the Trustee by:
